SCHEME AND SYLLABUS

- **♦** Assam Judicial Services Exam Eligibility Criteria:
 - > Applicants must have completed **LL.B** from any recognized institute.
 - > Age limit- Not more than 38 years (For SC/ST -5 years Relaxation)

SELECTION PROCESS:

- Preliminary Examination → Objective Type- multiple choice questions.
- Mains Examination → Subjective/narrative type
- Viva-Voce → Personal Interview
- **Exam Pattern-** The Examination Pattern will be as follows:

PRELIMINARY EXAMINATION

- The exam is of objective type and it consists of multiple-choice question.
 - ➤ It will consists of objective questions of **100 marks**, out of which **90 marks will** cover: -
 - General Knowledge, Aptitude, English,
 - ➤ Constitution of India,
 - Code of Civil Procedure,
 - ➤ Code of Criminal Procedure,
 - > Transfer of Property Act,
 - Indian Contract Act,
 - ➤ Indian Penal Code,
 - ➤ Indian Evidence Act,
 - ➤ Law of Torts

Remaining 10 marks to test the proficiency in the Official Language(s) of the State of Assam (Assamese).
