SCHEME AND SYLLABUS

- **Himachal Judicial Services Exam Eligibility Criteria:**
 - ➤ Applicants must have completed **LL.B** from any recognized institute.
 - ➤ The age Limit- 22 years and must not be more than 35 years. (For SC/ST /OBC- 3years relaxation)

SELECTION PROCESS:

- Preliminary Examination → **Objective Type**
- Mains Examination **subjective Types**
- Viva-Voce Personal Interview
- Exam Pattern- The Examination Pattern will be as follows:

PRELIMINARY EXAMINATION

- **❖** It will consist of Objective Type Questions.
- The examination consisting of the following three papers of 100 Marks each: -
 - Civil Law-I
 - Civil Law-II
 - Criminal Law
 - ➤ Each paper shall be of one-hour duration and the examination in all the three papers shall be held on the same day.
 - ➤ The syllabus for the preliminary examination shall be the same as provided for **Paper-I to III** for the Main examination

MAINS EXAM SYLLABUS

 - ➤ Main Written Exam consists of 5papers.
 - > Duration of each paper will be for **3 hours**.
